- A family membership is for members of the same household.
- A junior membership is for a person under eighteen years of age. The membership application must be co-signed by a parent or guardian.
- Membership fees are due April 30 of each year. If fees are not received by April 30, the membership is terminated. Any person whose membership is terminated may reapply for associate membership.
